She stated that Interim Superintendent of Schools, Dr. Olwen Heron and Chief Financial Officer, Kristina Berta, were available to answer any questions that the Board may have.

As the Board wished to hold its questions and comments until after the Public Hearing, Mr. Hipple proceeded to open the Public Hearing.

As no one wished to speak to the matter, Mr. Hipple closed the Public Hearing.



Mr. Onizuk thanked the school system for working with the County to meet the County's budget requirements. At the last budget work session, the replacement of school buses was discussed, and he is happy to see that plan moving forward under this spending plan. He is excited to see the plans coming forward for the Lafayette Auxiliary Gym and it seems that it is well supported by the Lafayette parents and students. He is happy to see some of these funds being used as part of the project. He stated that he will support this plan tonight.

Ms. Larson thanked the school system for its efforts in working efficiently. She is glad to see the School Liaison Committee back up and working to help facilitate communication and cooperation between the County and the school system. She agreed with the comments made by Mr. Onizuk regarding school bus replacement and will be happy to support the plan this evening.

Mr. McGlennon stated that he is happy to support this item this evening as it highlights the open working relationship between the County and the school system. He asked for clarity about what can be expected for the upcoming year. It seems that this plan will keep the bus replacement plan on track. He questioned if bus replacement would be part of the FY 18 school budget.

Ms. Berta stated that school bus replacement will not be included in the FY 18 budget. She stated that with projected State budget shortfall and mandatory increases in contributions to Virginia Retirement System, the schools did not want to add the burden of bus replacement to the upcoming budget. Hence, this request is for eight replacement buses which would keep the replacement plan on track.

Mr. Hipple thanked the staff from both the County and the school system for the way that everyone has worked together. He is happy to see the excess funds being re-invested in the schools and he will be supporting this item tonight.

Mr. McGlennon highlighted several events that he was able to attend over the last two weeks. He thanked all of the Dominion Power and Cox Cable workers that were out during the recent storm to get services back up and running. He also recognized the passing of Mr. Dick Cokely, a former Jamestown District Supervisor.

Ms. Larson recognized Ms. Kate Sipes and the Office of Economic Development for their efforts in coordinating the recent Manufacturing Day, which allows high school students to tour manufacturing businesses in the County. She also thanked staff and first responders for keeping the County going during the recent storm.

Mr. Onizuk thanked the first responders and the Dominion Power workers for their efforts during the storm. He voiced an on-going concern regarding the intersection at WindsorMeade Way. He reminded citizens about Oktoberfest, which is taking place at Anheuser Busch.

Ms. Sadler thanked staff and Dominion Power for their work during the storm. She announced that the Chickahominy Improvement Organization will be building a playground out in the Chickahominy area this weekend.

Mr. Hipple expressed his thanks to staff and first responders as well. He stated that the Day of Caring Event in Grove was a great success, and thanked all of the staff that participated. He gave an update on the Hampton Roads Transportation Planning Organization and Hampton Roads Planning District Commission.

1. County Administrator's Report

Mr. Hill gave an update on the Strategic Plan process and he thanked all of the citizens that participated in the process. He stated that the Strategic Plan will be coming before the Board for adoption at the second meeting in November.

Mr. Hill announced that the James Blair Middle School Groundbreaking Ceremony will take place on October 18. Also, on October 22, the Police Department will be participating in a drug take back event in conjunction with the DEA, which will take place at the Recreation Center on Longhill Road.

SUBJECT: Federal Grant Award - Bulletproof Vest Partnership - \$32,520

---

The James City County Police Department has been awarded a Bulletproof Vest Partnership (BVP) grant from the Office of Justice Programs' Bureau of Justice Assistance for \$32,520 (\$16,260 federal funds; \$16,260 local match). The funds are to be used to purchase approximately 30 new and replacement bulletproof vests for officers.

The Bulletproof Vest Partnership has typically been a recurring grant program made available each year to law enforcement agencies throughout the United States. This grant expires August 31, 2018, which allows us to replace vests as needed, or purchase vests for new officers throughout the grant period.

Each sworn officer within the Department is offered a bulletproof vest as part of their normal issued equipment. Unless recalls are made or the vest is damaged, the lifespan of vests is typically five years. The vests used by the Department are engineered for superior performance and integrate high-performance ballistic materials with a temperature regulating carrier for maximum comfort.

The grant requires a match of \$16,260, which is available in the Special Projects/Grants Fund.

Staff recommends adoption of the attached resolution to appropriate funds.

---

The Commonwealth Attorney has been awarded a \$189,015 grant (Federal share \$134,750; state share \$44,917 and County match \$9,348) from the Victim's Witness Grant Program through the State Department of Criminal Justice Services. The Grant will fund the personnel costs for the continuation of two full-time equivalent (FTE) positions as well as provide additional funding to upgrade a .50 FTE position funded by another grant to full-time (1.0 FTE). These positions provide comprehensive information and direct services to crime victims and witnesses. The Commonwealth Attorney has been successful in obtaining this grant for more than 11 years and plans to apply for this grant in the future.

The County match is available in the Commonwealth Attorney's general fund account.

The attached resolution appropriates these funds to the Special Projects/Grant Fund through June 30, 2017.

Staff recommends approval of the attached resolution.

WHEREAS, the Commonwealth Attorney for the City of Williamsburg and James City County has been awarded a \$179,667 federal grant from the Victim Witness Grant Fund (federal share \$134,750; state share \$44,917; County match \$9,348) through the State Department of Criminal Justice Services; and

WHEREAS, this grant would fund the personnel costs for the continuation of two full-time equivalent (FTE) positions as well as provide additional funding to upgrade a .50 FTE position funded through another grant to full-time (1.0 FTE); and

WHEREAS, these positions provide comprehensive information and direct services to crime victims and witnesses beginning July 1, 2016, through June 30, 2017; and

WHEREAS, the grant requires a local match of \$9,348, which is available in the Commonwealth Attorney's General Fund account.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of James City County, Virginia, hereby authorizes the upgrade of a .50 FTE position to full-time (1.0 FTE); and authorizes the additional appropriation to the Special Projects/Grants Fund for FY 17 purposes described above:
