Attached is a resolution formally accepting water and sewer systems constructed and contributed to the James City Service Authority (JCSA) by developers during FY 17. The resolution lists the value of the infrastructure at the time of completion. The total value of \$1,512,220 will be included in the net capital asset calculations for JCSA's FY 17 Comprehensive Annual Financial Report pending the Board's acceptance of the systems. JCSA had net capital assets totaling \$161,615,472 in the FY 16 Annual Report.
